- 1. I am over 18 years of age and competent to testify, of my own personal knowledge, to facts regarding this request for an Order of Confidentiality of Personal Information.
- 2. I am qualified to request an Order of Confidentiality of Personal Information in the Washoe County Assessor’s records, pursuant to NRS Chapter 247, because I am:
 - 1. _____(a) Any justice or judge in this State.
 - _____ (b) Any senior justice or senior judge in this State.
 - _____ (c) Any court-appointed master in this State.
 - _____ (d) Any judicial personnel of an Indian tribe.
 - _____ (e) Any clerk of a court, court administrator or court executive officer in this State.
 - _____ (f) Any county or city clerk or registrar of voters charged with the powers and duties relating to elections and any deputy appointed by such county or city clerk or registrar of voters in the election division of the county or city.
 - _____ (g) Any peace officer or retired peace officer.
 - _____ (h) Any prosecutor.
 - _____ (i) Any state or county public defender.
 - _____ (j) Any person employed by the Office of the Attorney General who prosecutes or defends actions on behalf of the State of Nevada or any agency in the Executive Department of the State Government.

_____ (k) Any person, including without limitation, a social worker, employed by this State or a political subdivision thereof, who as part of his or her normal job responsibilities:

- (1) Interacts with the public; and
- (2) Performs tasks related to child welfare services or child protective services or tasks that expose the person to comparable dangers.

_____ (l) Any county manager in this State.

_____ (m) Any inspector, officer or investigator employed by this State or a political subdivision of this State designated by his or her employer:

- (1) Who possesses specialized training in code enforcement;
- (2) Who, as part of his or her normal job responsibilities, interacts with the public;
- (3) Whose primary duties are the performance of tasks related to code enforcement.

_____ (n) The spouse, domestic partner or minor child of a person described in paragraphs (a) to (m), inclusive.

_____ (o) The surviving spouse, domestic partner or minor child of a person described in paragraphs (a) to (m), inclusive, who was killed in the performance of his or her duties.

_____ (p) Any person for whom a fictitious address has been issued pursuant to NRS 217.462 to 217.471, inclusive.

2. Any nonprofit entity in this State that maintains a confidential location for the purpose of providing shelter to victims of domestic violence.

3. By virtue of my status and position as described in paragraph 2, I (or my spouse, domestic partner or minor child) am/was required to take actions to enforce, administer or adjudicate the law and subject others to the legal consequences of their actions.
4. In doing so, I and/or my family can be exposed to possible retribution, retaliation, threats, fraudulent and frivolous legal filings and proceedings, harassment or violence by persons who are subject to or affected by such law enforcement actions.
5. To protect myself and my family, and to minimize the risk of danger, I am requesting that this Court issue an Order directing the Washoe County Recorder to remove from public access, including internet and electronic records, and hold confidential my personal information contained in real property records and marriage certificates, as defined in NRS Chapter 250.120, including the home address, telephone number or electronic mail address, of myself, my spouse, my domestic partner or my minor child, and any information pertaining to a confidential location maintained by a nonprofit entity in the State of Nevada for the purpose of providing shelter to victims of domestic violence, and not to disclose or reveal said information to others except pursuant to NRS 239.0115.
